



OFFICIAL RULES CORTINA DOBBIACO RUN 2 JUNE 2024

A.S.D. F.O.R. organizes the 24th Cortina Dobbiaco Run, a 30 km trail, part of the Fidal (Italian Athletics Federation) National Calendar. The event will take place on 2 June 2024, starting at 09:00 a.m. from Corso Italia, Cortina d'Ampezzo, with arrival at Grand Hotel Park in Dobbiaco

REGISTRATION OF ITALIAN ATHLETES RESIDING ANYWHERE, AND FOREIGN ATHLETES RESIDING IN ITALY

In accordance with FIDAL regulations for the organization of events, participation is open to all the following Italian athletes (residing both in Italy and abroad) and non-Italian athletes residing in Italy, who are at least 20 years old on the date of the Cortina Dobbiaco Run (2 June 2024):

a) Athletes that are members of associations affiliated to FIDAL, in the different competitive and promotional activities. In case of registration before the renewal of the membership, the athlete shall forward as soon as possible copy of the FIDAL 2024 renewal form, indicating the membership card number.

b) Athletes with Fidal Runcard. Athletes must forward a doctor's certificate confirming fitness for sports competitions, specifically containing the wording "ATHLETICS", during the registration phase or subsequently directly on the ENDU portal. The original certificate must also be presented upon collection of the racing bib. These athletes shall be excluded from the awarding of both category and absolute prizes.

c) Athletes that are registered members for Sports Promotion Bodies (Enti di Promozione Sportiva - EPS), only if in possession of appropriate "EPS RUNCARD" issued by Fidal. These athletes must forward a doctor's certificate confirming fitness for sports competitions, specifically containing the wording "ATHLETICS", during the registration phase or subsequently directly on the ENDU portal. The original certificate must also be presented upon collection of the racing bib. These athletes shall be excluded from the awarding of both category and absolute prizes. Athletes with EPS membership only are not eligible to take part in the event.

REGISTRATION OF ATHLETES WITHOUT ITALIAN MEMBERSHIP

Registration is open to Italian/foreign athletes without Italian membership who are in their 20th year of age and meeting at least one of the following requirements:

- Athletes with membership to a club affiliated with non-Italian Athletics Federations recognized by World Athletics. Upon registration, athletes must present self-certificate stating possession of an WA recognized membership card. The self-certificate shall then be undersigned (in original) upon collection of the racing bib.

- Athletes possessing a Runcard (valid as sports insurance and permission to complete), who are at least 20 years old. However, in addition to the possession of the "RUNCARD", permission to take part in the event is also subjected to the presentation of a valid doctor's certificate confirming the fitness of the athlete for participation to athletic events.

The original certificate must be shown to the Organizers, while a copy must be kept by the company organizing event.

For foreign athletes not residing in Italy, the doctor's certificate may be issued in their country of residence, provided that all the exams contemplated by Italian law are carried out:

- a) medical check-up;
- b) complete urine test;
- c) electrocardiogram at rest and under stress;
- d) spirometry

During the ON-LINE registration, the certificate form will be provided in EN-DE. This must be filled and undersigned by the doctor and forwarded to: cortinadobbiacorun@evodata.it. Incorrect documentation shall result in the exclusion of the athlete from the competition, without any refund for the registration fee paid.

The Organizers will only accept ON-LINE registrations through the ENDU portal paid by credit card or bank transfer.

QUOTE REGISTRATION FEES

The registration fee will increase according to the achievement of a predetermined membership threshold, according to this scheme:

Cortina Dobbiaco Run 2024

- from 001 to 500 - € 40
- from 501 to 1.000 - € 45
- from 1.001 to 1.500 - € 50
- from 1.501 to 1.800 - € 55
- from 1.801 to 2.000 - € 60

REGISTRATION CLOSING DATE

Registrations will close on Wednesday 29 May 2024 at midnight. Registration by bank transfer until 25 May 2024.

The Organizers reserve the right to close registrations early, as soon as the maximum number of 2.000 participants has been reached.

A registered athlete who, for various reasons, cannot take part in the race will have two options:

CHANGE OF NAME: It will be possible to make the name change at a cost of € 10 until 25 May, beyond that, no request will be considered.

TRANSFER TO 2025: It will be possible to transfer at a cost of €15 until 25 May, after which no request will be considered. For both exchange and transfer please write to: cortinadobbiacorun@evodata.it

- Saturday 1 June from 9:00 a.m. to 7:00 p.m. at the Grand Hotel in Dobbiaco.
- Saturday 1 June from 2:00 p.m. to 7:00 p.m. in Cortina d'Ampezzo
- Sunday 2 June from 7:15 a.m. to 8:30 a.m. in Cortina d' Ampezzo.

During the registration you will be asked where you will collect your bib number. Possibility to receive the bib number at home at the cost of € 10,00 by writing to: cortinadobbiacorun@evodata.it.

ALLOCATION OF STARTING RULES

There will be three starting grids.

Participants will have different colored bibs and will be placed in the grids on the basis of the times obtained in previous editions or the personal bests declared during the registration procedure on the half marathon and marathon.

It will be possible to relegate to another start, but not to advance, under penalty of disqualification at the finish line, with no inclusion in the final classification.

TIMING & CHIP

Times will be recorded using a microchip, which also gives the possibility of recording the actual time. Chips are strictly personal and cannot be swapped.

Competitors not going through the checkpoints shall be disqualified. Chips must be worn on the chest. Their removal shall result in exclusion from the standings.

REFRESHMENT STOPS

There will be five refuels, approximately every 5 km

DISQUALIFICATION

Participation using the racing bib of another runner, giving the racing bib to someone else, short-cuts, or any other serious breaches identified by the Organizers, shall result in exclusion from the competition and disqualification, in addition to other disciplinary measures contemplated by FIDAL. The racing bib number cannot be removed or reduced.

INSURANCE

The Organisers have undertaken third party civil responsibility insurance policies for individual injuries.

AT THE ARRIVAL

Athletes arriving regularly at the finish line will receive the official race medal, food parcel and bag with personal belongings. The rankings and the participation diploma (printable by the participant) will be available free of charge on www.endu.net.

Changing rooms in the finish area, showers at the Nordic Arena, via al lago 1, 700 m from the finish line.

PRIZES

Prizes will be awarded to the first 5 men and the first 5 women in the general classification, these will be excluded from the category prizes.

In each category, prizes will be awarded to the first 3 male and female finishers.

No cash prizes (or similar: generic value vouchers, bonuses, engagements, reimbursement of expenses of any kind and for any reason whatsoever) may be awarded to "Runcard" and "Runcard EPS" holders.

Individual and club prizes must be collected during the prize-giving ceremony and cannot be claimed later.

Total prize money in B.V. € 2,500.00 divided as follows:

CLUB AWARDS

Prizes will be awarded to the first 3 clubs with the highest number of classified athletes at the finish line.

COMPLAINTS

Any complaints must be forwarded to the Organizers by 2:00 p.m. (2 June 2024), together with a fee of € 100.00, which will be returned upon acceptance of the complaint.

RUN CANCELLATION

In case of cancellation or postponement of the run due to reasons outside the control of the Organisers, including the withdrawal of authorisation from the competent authorities, no reimbursement may be requested to A.S.D.

F.O.R., including for any expenses sustained or that will be sustained. It must in fact be noted that the undersigning of the registration for participation also constitutes a declaration of waiver of any claims for damages and/or compensation and/or any reintegrating and/or satisfactory pretence of any patrimonial damages suffered, or which will be suffered.

IMAGE RIGHTS

In registering for taking part in the 24rd Cortina Dobbiaco Run, the athlete expressly grants to the Organizers and any legal entities with whom the same entertain professional and commercial relations relating and connected with the taking of images of the event, free rights for the use of still images or video feeds on which he/she may appear, shot during his/her participation to the Cortina Dobbiaco Run, on any visual supports, as well as on promotional and/or advertising materials produced and distributed all over the world, for the maximum period of time contemplated by the law, the regulations and the treaties in force, including any extensions that may be applied to the legally set period.

RESPONSIBILITIES AND PRIVACY

By registering his/her participation to the Cortina Dobbiaco Run, the athlete hereby confirms full knowledge and acceptance of these rules, that everything he/she states is the truth, and to relieve the Organizers from all civil and criminal responsibility for any damage to people and/or property that he/she may cause, or that may result from his/her actions. Information notices according to Art. 13 of Legislative Decree 196 of 30/06/2003 – Protection of privacy.

For anything not contemplated in these rules, specific regulations and the current legislation shall apply. The Competition Judging Team shall be entitled to disqualify any athletes that will not pass through the detection points along the route. For anything not contemplated in these rules, the statutory norms, and regulations of FIDAL (Federazione Italiana di Atletica Leggera) shall apply. The Organizers reserve the right to modify these rules for their improvement. Any changes will be published in real time on the official website: www.cortinadobbiacorun.it.

FINAL WARNINGS

The Organizing Committee reserves the right to amend these regulations at any time for reasons it deems appropriate, for a better organization of the race, after having given notice and obtained approval from FIDAL. For anything not provided for in these regulations, the statutory technical regulations of FIDAL and the G.G.G. shall apply. Any changes to services, places and times will be duly communicated to the registered athletes or will be reported on the website www.cortinadobbiacorun.it.
